The Member Death Benefit Programme (MDBI) comes into effect in January and July of each year.

As this is a Community Programme, First Tech Credit Union is required to deduct €88.00 annually from each participating member. (Joint account holders must complete and sign separate forms)

This cover from January-December is not automatic, so you must *OPT-IN* to join and give permission for us to deduct the policy premium from your Share Account. This premium will auto renew unless otherwise instructed and be deducted in January each year.

OPT-IN for a combined €4,500 Guaranteed

We advise you to OPT-IN, as this *Member €3,000 Death Benefit*, combined with members' existing *First Tech Credit Union Life Savings Benefit*, will provide a *minimum of €4,500** for your dependents.

*Terms and conditions apply

All members wishing to avail of this optional €3,000 need to sign and send a fully completed **OPT-IN Form** to First Tech Credit Union, 55 Dawson Street, Dublin 2. New members may sign up half yearly on January 1st or July 1st with the premium taken on a pro rata basis in the first year and on January 1st for each year thereafter.
