Once you've joined, please refer a family member by registering their details on the form (see link below) and ask them to join before the closing date of the promotion.

### HOW DOES IT WORK?

As the referring member, you must register your details and the details of the person you are referring by completing our registration form at [www.firsttech.ie/refer-a-family-member-win](http://www.firsttech.ie/refer-a-family-member-win).

The referred person (your family member) must download the First Tech Credit Union app from the App Store or Google Play and complete the membership form by **Friday 27th February 2026**. The application must include a valid proof of identification, proof of address and a minimum of €10 must be lodged into the Share Account.

Once your family member's membership is activated, we'll add both of you into our draw for the €250 One4all gift card and we'll add €50 into the referring member's Share Account.

### TERMS & CONDITIONS

- Participants in the draw must be 18 years of age or over and living in the Republic of Ireland. There will be one draw entry per member.
- This promotion is valid for new referrals who become members during the promotion period only. The promotion is void if the referred member is an existing First Tech Credit Union member, was a member at any time in the previous 6 months or has a joint account with First Tech Credit Union.
- The referring member must complete the registration form to be eligible for the draw.

- The referred person must be a direct family relation of the referring member. If not, the application for membership will be rejected and the €50 will not be paid into the referring member's Share Account.
- There will be 1 prize of a €250 One4all gift card. The gift card will be posted to the winner or can be collected in branch. The gift card must be redeemed by the expiry date stated on the card. There is no cash alternative.
